

Sample Lead Generation:

1. All of these leads contained an e-mail address, first & last names, mailing address, and phone number which were deleted from this sample
2. All of these people downloaded the sponsored White Paper of one client.
3. All leads were transmitted to the client in real-time
4. The last column: Classification Status is a pre-set feature which tells you right away if the lead is “junk” based on the parameters you set

These are the three custom questions that the client gets to ask before their White Paper can be downloaded
